USAG-WI State Legislation

State Meet Bids – Failure to submit State Meet bid forms prior to the published deadline results in one week of statewide open bidding for the meet with bid winner also retaining their scheduled rotational position. The club forfeiting the meet moves to the bottom of the rotation.

Motion – Jane Schrimpf; 2nd – Kathy Nelson; Passed

Delinquent Head Tax – Meet directors failing to submit head tax to SACC within one week of the meet will be issued one written warning. If still delinquent one week after the written warning, the offending club will not be awarded a meet on the state schedule (Compulsory qualifier) the following season.

Motion – Jane Schrimpf; 2nd – Kathy Nelson; Passed

Clarification: Age Determination date for the Compulsory season is the last day of State Meet.

Motion to include this statement in the State Rules & Policies where Age Divisions are published – Ellen Hendrickson; 2nd – Jane Schrimpf; Passed.

Qualification to Xcel State Meet – changed to participation in *one* seasonal meet or by petition to SAC effective 2016-17. Motion – Jane Schrimpf; 2nd – Kathy Nelson; Passed.

Gate Fees –Compulsory Qualifiers & State Meets

Maximum to be charged per day:

- In-house (Compulsory Qualifiers & State Meets)
 - \$7 Adults
 - \$3 Students (age 5-17)
 - \$5 Seniors (age TBD by meet director)
- Off-site (Compulsory qualifiers & all State Meets)

\$10 Adults

\$5 Students (age 5-17)

\$8 Seniors (age TBD by meet director)

2-day discount passes at meet director’s discretion.

Motion to adopt these maximum gate fees for Compulsory qualifiers and all State Meets.

Xcel In-House State Meet Entry Fee - \$45

Motion to eliminate the “or up to \$65/\$75 with SAC approval for in-house.”

Other Business

2016 Level 9/10 State Meet – 2-Judge Panels

Wisconsin will not be able to field 4-judge panels for the 2016 State Meet.

Submit Compulsory Meet Date Requests to SACC by **Mar. 1 Deadline**. Include 3 choices of dates, facility/location and any other pertinent info.

Notify SACC of Optional Meets as soon as you schedule them so they can be posted on the state Google calendar. Send SACC a link to the meet info as soon as it’s available. Recommendation – post a link to meet info on your home page where it can be easily found.

Meet Entry Forms – If using the USAG download to enter meets, verify correct information, e.g., correct levels. Do not submit entry forms with conflicting information or formats when sending entry fees to meet directors.

Meetmaker – was presented as a potential online meet entry program. USAG-WI does not endorse this program which requires ACH or credit card payment only. No additional service charges or fees may be tacked onto USAG-WI Compulsory Qualifier or State Meets entry fees.
