II. Approve minutes of 5-3-19 Meeting

III. State Financial Update – Current balance \$26,000 prior to head tax collection. Anticipating approximately \$9700-Compulsory and \$8000-Optional head tax income. With expenditures for Regional head tax and apparel we’re expected to break about even at \$2500 (without including clinics).

IV. Head Tax Review – Remains the same for 2020-2021 as last year:

- Level 2-5 Compulsory season meets only tax Compulsory athletes (Xcel excluded).
- Optional season meets (after L2-5 State Meet) only tax L6-10 and Xcel athletes (L2-5 excluded).
- All State Meets are exempt from paying head tax.

V. Compulsory Season Recap

- Numbers are down possibly due to Xcel drawing athletes from Compulsories.
- Income
  - This Year \$9700
  - Last Year \$11,468

VI. Compulsory Qualifier Schedule

- **“Request for Meets”** date **Deadline is changed to April 1**(from March 1)
  - Levels/Divisions being offered at meets must be included on the Meet Request form
- Judges’ Invite weekend will be Sept. 12-13, 2020 (late Labor Day).
- **L2-5 State Meet** weekend – **Dec. 5-6, 2020** hosted by SAGA
- Xcel fall schedule – Xcel Divisions being offered must appear on the Meet Request form.

VII. Miscellaneous items

- Should **Xcel Bronze** have a lower meet **Entry Fee**? (Currently, \$50)
  - **No Change** at this time
- Should **Team Trophies** at Compulsory qualifiers be done away with?
  - **No change.** Leave it as is.
- Should an exception be made for the **30-day refund policy** for **athletes that quit**?
  - **No change.**
